

## Terms and Conditions: Competition Willy Wonka & the Chocolate Factory

16 December 2021

1. The Royal Dutch Mint, located in Houten, organises giveaways and other promotions. On all giveaways and other promotions terms and conditions apply. By entering a giveaway or other promotion, the participant agrees with the terms and conditions below.
2. Every participant can only enter the giveaway or other promotion once.
3. The mintage of the Willy Wonka & the Chocolate Factory medal in coincard contains five gold-plated medals instead of the standard cupro-nickel. The finders of the gold-plated medals win a tour of the factory of the Royal Dutch Mint in Houten.
4. The tour is guided by an employee of the Royal Dutch Mint. Prior to the tour, the winner is required to show a valid ID. It is not allowed to take photos or other visual material during the tour.
5. The giveaway will end when all five gold-plated medals have been found.
6. Participants are obligated to provide correct, up-to-date and complete information upon entering the giveaway or other promotion.
7. Participants must comply with the Advertising Code Social Media.
8. In order to be able to participate, the participant has to be 18 years or older. Participants under the age of 18 must have obtained permission from parent(s), caregiver(s), guardian(s) or other legal representative(s) to participate. All other participants are excluded from participation.
9. The gold-plated medals have been distributed randomly and impartially in the mintage of the Willy Wonka & the Chocolate Factory Medal in Coincard.
10. The finders of the gold-plated medals must report themselves to the customer service department of the Royal Dutch Mint via [klantenservice@knm.nl](mailto:klantenservice@knm.nl). Proof must be provided that the gold-plated medal is actually in the possession of the winner, for example in the form of a photo of the gold-plated medal that has been found. The Royal Dutch Mint will return an email within a reasonable time to schedule the tour. The winner must respond to the email from the Royal Dutch Mint within 7 days.
11. If the winner does not respond within the aforementioned deadline, their right to the prize will be withdrawn.
12. The Royal Dutch Mint may, at its own discretion and without prior notice, change or adjust these promotional terms and conditions during the promotional period, or change or amend the promotion without giving any reason unless this leads to the participant being disadvantaged.
13. There will be no correspondence about results.
14. Prizes cannot be exchanged for money or other goods.
15. If gambling tax has to be paid, the Royal Dutch Mint will take care of this.
16. Employees of the Royal Dutch Mint are excluded from participation.
17. The personal data obtained in the context of giveaways will only be used by the Royal Dutch Mint for the relevant promotion and will not be passed on to third parties.
18. In cases not provided for by these terms and conditions, a decision will be taken by the Royal Dutch Mint.
19. These terms and conditions are governed by Dutch law.
20. Participants who do not meet the above conditions can be excluded from participation.
21. The Royal Dutch Mint cannot be held liable for how the winner chooses to use the prize.
